### **CHAPTER – 1**

#### INTRODUCTION

#### 1.1 Introduction

History of computer-based Learning Computer assisted learning, or CAL is not a new phenomenon. Computer Assisted Learning can be defined as a computer program or the file developed specifically for educational purposes. It is used throughout the world in a context, from primary school to university level education. In the 1980s, the first computer assisted learning became available to university students. Various Committees and Commissions have recommended the use of technology for enhancing teaching learning processes.

The various commission and committees reviewing education have also felt the need and importance of educational technology in the school curriculum. The National Primary Education has emphasized computer literacy. It states that

"As computer has become an important ubiquitous tool, a minimal exposure to computer and training in their use will form a part of professional educational education. Programs of computer literacy will be organized on a wider scale from the school stage."

Computer literacy is defined as the knowledge and ability to use computers and related technology efficiently, with a range of skills covering levels from elementary use to programming and advanced problem solving. Computer literacy can also refer to the comfort level someone has with using computer programs and other applications that are associated with computer. Another valuable component of computer literacy is to know how computers work and operate. Having basic computer skills is a significant asset in the developed societies.

Computers are used to enhance a variety of skills among learners, including language learning. According to Tomlinson and Roadman (1974), language is the system by which sound and meaning are related; language communication and human needs are unquestionably linked. ### 2) Package

'Package' means a set of materials for teaching and learning.

In the present research, the learning package refers to activities and materials for 7 sessions, the content of which is based on some topics of the syllabus for the English method of Gujarati Medium B.Ed. course at the Sardar Patel University.

# 1.6 Type of Research

The present research is an exprimental study. It is be a single group pre-test post test exprimental design.

# 1.7 Objectives of the Study

The research was carried out with the following objectives in focus.

- To study various Computer Assisted Learning (CAL) packages already prepared by experts with a view developing insights into preparation of CAL materials
- To develop a Computer Assisted Learning (CAL) package for teaching English to pre service teachers Gujarati medium B.Ed. course
- To implement the Computer Assisted Learning package for teachig English to the pre service teachers

- To enable pre service teachers to use English
- To study the effectiveness of the Computer Assisted Learning(CAL) package in terms of achivement of pre service teachers through comparison of scores of pre and post tests.

In the present researcher 'Dependent Variable' was the achvivement score measured at the end of the experiment.
